## Textbook Rental Agreement

The KPC Campus Bookstore is pleased to offer a textbook rental program. The Textbook Rental Program allows students to rent textbooks for the duration of one (1) semester. Rental textbooks are available for select titles and are in limited quantities.

**Your completion of the rental transaction acknowledges your agreement to the following terms and conditions:**

1. **Requirements** – I am 18 years of age, currently enrolled at UAA, and have a valid UAA Student ID.
2. **Condition of Textbooks** – Rental textbooks are the property of the KPC Campus Bookstore. I am responsible for proper care of rental textbooks. I will return the same textbook(s) to the Bookstore in resalable condition. No tears, water damage, physical damage to the cover, pages, spine, or excessive writing or highlighting.
3. **Refunds** – If for any reason, I return the rental textbooks for a refund (dropped class, wrong book, etc.), I will do so within the regular textbook refund period. (**NOT** the rental return date). The refund period is the Thursday before the Add/Drop class deadline, **January 25<sup>th</sup>, 2018**.
4. **Late Returns**: I will be charged a \$20 fee if the textbook is not returned by the rental return date, **May 3<sup>rd</sup>, 2018**. If the book is not returned on or before the return date, it will be considered a failure to return (see #5).
5. **Failure to Return** – If I fail to return rented textbooks by or on **May 3<sup>rd</sup>, 2018**, the full price of the book minus any paid rental fees will be charged to my student account in addition to the late fee of \$20.
6. **Purchase of Rented Books** – I can purchase rental textbooks any time before the end of the rental period, **January 25<sup>th</sup>, 2018**. If purchased before the end of the rental period, I will pay the difference between the retail price and what I have paid in rental fees. Purchase price will be based on the current retail price.
7. **Rental Returns Date** – I am responsible for complying with the Rental Return Date. The KPC Campus Bookstore is not responsible for reminding me of the Rental Return Date. Any and all notifications are a courtesy.
